

BOARD OF HEALTH REGULATION R1-2023

A REGULATION OF THE SPRINGDALE BOARD OF HEALTH AMENDING BOARD OF HEALTH REGULATION R1-2022 WHICH ESTABLISHED FEES FOR FOOD SERVICE OPERATIONS, RETAIL FOOD ESTABLISHMENTS, VENDING MACHINE LOCATIONS, TEMPORARY FOOD OPERATIONS, AND MOBILE FOOD OPERATIONS WITHIN THE CITY OF SPRINGDALE; AND ESTABLISHED FEES FOR FOOD SERVICE OPERATION AND RETAIL FOOD ESTABLISHMENT PLAN REVIEWS.

Whereas, local boards of health are authorized by Sections 3717.25 and 3717.45 of the Ohio Revised Code to establish fees for the licensing, inspection, and plan review of Food Service Operations, Retail Food Establishments, Vending Machine locations, Mobile Food Operations, and Temporary Food Operations, and,

Whereas, the Springdale Board of Health wishes to revise the license fees in accordance with Section 3701-21-02 of the Ohio Administrative Code,

Now, therefore be it resolved by the Board of Health of the City of Springdale, State of Ohio, _____ members appointed thereto concurring;

Section 1: That the Springdale Board of Health hereby adopts the fees set forth on Exhibit A and incorporated herein by reference.
