# Minutes of the Board of Health Meeting

Minutes of the October 12, 2023 Board of Health meeting were presented. It was decided that since the members that were present were not all at the prior meeting, the October 12, 2023 minutes would be presented at the December 14, 2023 meeting.

#### City Council Report

Mr. Jacobs gave the City Council Report. He discussed the purchase of equipment for the Public Works Department. Surplus equipment from various departments was also released for purchase by the public. A new Public Defender had been hired for Mayor's Court. New Council members will be incoming and sworn in at the December 1, 2023 special City Council meeting. Mr. Jacobs stated that because of the changes in Council members, there will be changes in committees, boards and commissions.

#### Health Commissioner's Report

#### **Nuisances, Animal Bites, and Food Illnesses**

Mr. Clayton asked the Board of Health members if they had any questions on the complaints that were included in their Board of Health packet provided to them. There were no questions.

# **COVID-19 Cases**

Mr. Clayton gave an update on the amount of COVID cases. He stated that COVID cases are beginning to slow down once again after an uptick once school was back in session.

# Medicaid Administrative Claiming (MAC) Program

Mr. Clayton gave information regarding the amounts that will be received in the first two quarters. The amount was \$24,103. The MAC time study for September yielded \$25,340. The fourth quarter MAC time study will be occurring from November 12 through November 18.

# **Food Program**

Mr. Clayton stated that Dave and Busters, as well as Dunkin Donuts are currently looking to do kitchen remodels. Those plans have been approved with the remodels pending. Mis Raices Supermercado has a plan review pending. Mr. Clayton also stated that Turkeys R Us had recently closed and another individual is looking to use the space.

# **Board of Health Regulations**

Mr. Clayton asked Mayor Webster if they could go ahead and have a second as well as a third reading of the regulations due to the upcoming SOS Adopt A Family Christmas Gift Program. There was discussion as if that was allowable to have both readings. Mayor Webster confirmed that on occasion Council has done that as well and there have been no issues with that. It was agreed to go ahead with a third reading following the second reading of each Regulation.

# **Hamilton County Overdose Report**

Nurse Ellis asked if any Board of Health members had questions regarding the Hamilton County Overdose Report. There were no questions. Nurse Ellis stated that at the time of preparing the Board of Health Packet, the Narcan Report was unavailable. Since that time, Nurse Ellis received an update and stated that there were four instances of the use of Narcan for the month of October. Nurse Ellis asked Assistant Fire Chief Williams to see if there was an explanation for the uptick of Narcan usage, but he could not show any viable reason for the change at this time.

# **Communicable Disease Report**

Nurse Ellis asked if there were any questions. There were none.

#### **COVID 19 Vaccines**

Nurse Ellis stated that there is very limited requests for the current vaccine. Of the ten vaccines that were given to the Springdale Health Department, only seven were used. Nurse Ellis stated that individuals that want to schedule appointments for the COVID vaccine can either come in during the regularly scheduled Wednesday VFC (Vaccines for Children) clinics that are held on the first and third Wednesday, or call Amy directly to schedule according to the Nurse's availability. The only requirement is that adults that are requesting the vaccine must be uninsured. Those individuals with insurance must go to local pharmacies or their family physician.

# **Miscellaneous Articles and Press Releases**

Nurse Ellis discussed recent articles and press releases that she included in the Board of Health Packet, as well as her letter of resignation from the Springdale Building Department since she will be moving on to the Hamilton County Health Department.
