UNFINISHED BUSINESS

Review of request from Carolyn Pierson to replace garage door

Mayor Webster said originally he had stated that Ms. Pierson said she need a new garage door which he said didn't look bad. Ms. Pierson stated what she was really asking for was replacement of the side garage door. The board agreed to grant her request. Mrs. Mitrione is to contact her and let her know.

Mr. Moore and Mrs. Barnett have been paid. Mrs. Davis has been approved and the work has been done but nothing has been submitted for reimbursement yet. Mrs. Bagadi has been approved but has not had her tree cut down yet.

Rob Westerman said he talked with Ms. Haley and she seemed confused. He said there is rotted out privacy fence on the sides and chain link in back. Her request is to tear down and replace the chain link fence. According to Brian Ward, Property Maintenance inspector who had talked with Ms. Haley, the fence to the right of Ms. Haley belongs to the neighbor and the neighbor on the left side has agreed to replace that fence as he has dogs.

Rob Westerman said he could have a group take the chain link fence down if the City could provide a dump truck to dispose of the fencing. SOS will not replace the fence.

Christmas Program

Mayor Webster asked that Barbara send the donation request letter SOS used last year and members of SOS. Mayor Webster will hand it to the vendors at the Chamber Business Expo and Julie Matheny will e-mail it to Chamber members. She will also put it on the Chamber website. The Health Department will make sure it gets on the City website and Joe Ture can send it to the neighborhood wtch list.

TREASURER'S REPORT

Julie Matheny reported the beginning balance of the general fund as of 5/16/12 was \$13,571.10. Interest earned was \$6.81. Money paid out was: \$250 to SOUL Ministries for backpack program; \$500 to Rosemary Barnett, community improvement and \$500 to Rain-A-Way, community improvement. The ending balance is \$12,327.91.

The balance of the Christmas fund as of 4/18/12 was \$940.74. Interest earned was \$0.23 and \$100 in donations was received from Kathy McNear. The ending balance is \$1,040.97.

GROUP DISCUSSION

Rob Westerman said they have an Upward Basketball Program and wanted to get more Springdale kids involved. He said people were going to The Willows and Colony to promote it and wanted to know if it is okay for people to have signs in their yard promoting the program. Mayor Webster said yes, it is.

Barbara Thetford said she had already received a phone call about the community improvement program. The board said to have people call back in March to see if we are going to have the program.
