**OLD BUSINESS**

**Sue Nassar**

Carolyn Ghantous gave an update on the current maintenance situation at Sue Nassar's house. People Working Cooperatively (PWC) applied for a permit through the Springdale Building Department. Work was not completed yet. Gutters should be completed next week or so. All S.O.S. items that organization committed to are in process.

**Home Improvement Assistance for Senior Citizens**

Another potential candidate for assistance would be Mrs. Brandenburg. Keenan Riordan was notified by one of her neighbors. It was unclear if she was in need of monetary assistance. It was discussed that S.O.S. may be able to have people to do the repairs if supplies are provided. Perhaps Meals on Wheels would be a good idea for Mrs. Brandenburg. Keenan Riordan stated intent to contact Josh Howard of the Council on Aging for further information.

Matt Clayton will create a flyer with information for Springdale senior citizens regarding organizations who can assist with home improvement opportunities, including S.O.S., People Working Cooperatively, and the Springdale Home Improvement Grant Program. Matt stated intent to seek permission to post this information on the City of Springdale's website and the Facebook page for the City of Springdale.

The S.O.S. board members discussed the benefit of having members of the faith based community join the S.O.S. board. Matt Clayton stated intent to reach out to representatives from Compass Church and the Vineyard Cincinnati Church regarding their possible involvement.
